## TEJ YAM MUAJ TSEEB

- 47% ntawm cov me nyuam kawm ntawv nyob rau hauv lub Nroog Dane Qhov Kev Kuaj Ntsuas Cov Me Nyuam (Dane County Youth Assessment) qhia tawm tias lawv haus ib qhov dej qab zib (sugary beverage) tsawg kawg li 1-3 zaug nyob rau lub vas thiv dhau los no.
- Tsawg dua ib-peb ntawm cov me nyuam yaus (children) thiab cov me nyuam hluas (teens) thiaj li haus dej txaus txhua hnub.
- Ib qhov kev tshawb fawb (study) nyuam qhuav ua tas no tshawb pom tias thaum cov tsev kawm ntawv muaj dej pub dawb los ntawm ib qhov chaw twg uas tsis yog-lub cav nias dej tawm es mam haus (non-fountain source), tus leb feem pua (percentage) ntawm cov me nyuam kawm ntawv uas haus dej coob tuaj li ob tauj.
